



THESE TERMS AND CONDITIONS APPLY TO ALL SERVICES BY CURIOUS CONCEPTS TO THE CLIENT.

Acceptance

It is not necessary for any Client to have signed an acceptance of these terms and conditions for them to apply. If a Client accepts a quote then the Client will be deemed to have satisfied themselves as to the terms applying and have accepted these terms and conditions in full. Please read these terms and conditions carefully. Any purchase or use of our services implies that you have read and accepted our terms and conditions.

Quotations

Charges for services, software, hardware to be provided by Curious Concepts are defined in the project quotation that the Client receives via e-mail. Quotations are valid for a period of 14 days. Curious Concepts reserves the right to alter or decline to provide a quotation after expiry of 14 days.

Turnaround Time and Content Control

The client agrees to delegate one person as a primary contact to aid Curious Concepts with the progressing the commission in an acceptable and convenient manner. During the project, Curious Concepts will require the client to provide website content, images, and other relevant information.

Curious Concepts is a small business, to remain efficient we must ensure that work we have programmed is carried out at the scheduled time. This is why we ask that you provide all the required information in advance. On an occasion where progress cannot be made with your website because we have not been given the required information in the agreed time frame (30 days after initial payment), and we are delayed as result, we reserve the right to impose a surcharge of up to 25%.

If you agree to provide us with the required information and subsequently fail to do within one month of project commencement we reserve the right to close the project and the balance remaining becomes payable immediately. Simply put, all the above condition says is do not give us the go-ahead to start until you are ready to do so.

If a graphic artwork is not completed within 60 days, a 50% rejection fee be will be charged.





Payments

Unless agreed otherwise Curious Concepts asks for a 50% deposit for any new client before any work is supplied to the client for review. If the option of a down payment is selected the work will only be commenced once a payment plan has been discussed, approved and set up on the Curious Concepts Accounting side.

This includes all graphic design/ website design/ programming/ printing services. The remaining 50% of the project quotation total due upon completion of the work, prior to uploading to the server or release of materials. Once a website is live, payment is due.

Invoices will be provided by Curious Concepts upon completion but before publishing the live website. No final graphic artwork will be delivered if previous invoices are still outstanding. Invoices are sent via email. Invoices are due within 7 days upon receipt.

Payment for services is due by bank transfer. Bank details will be made available on invoices.

Additional expenses

Client agrees to reimburse Curious Concepts for any additional expense necessary for the completion of the work. This will always be discussed before would be purchase any software, hardware, special fonts, stock photography etc.

Web Browsers

Curious Concepts makes every effort to ensure websites are designed to be viewed by the majority of visitors. Websites are designed to work with the most popular current browsers (Eg. Firefox, Google Chrome, Safari etc.) Client agree that Curious Concepts cannot guarantee correct functionality with all browser software across different operation systems.

Curious Concepts cannot accept responsibility for web pages which do not display acceptably in new versions of browsers released after the website have been designed and handed over to the Client. As such, Curious Concepts reserves the right to quote for any work involved in changing the website design or website code for it to work with updated browser software.





Default

Accounts unpaid thirty (14) days after the date of invoice will be considered in default. If the client in default maintains any information or files on Curious Concepts web space, Curious Concepts will, at its discretion, remove all such material from its web space and put the account under suspension. Curious Concepts is not responsible for any loss of data incurred due to the removal of the service. Removal of such material does not relieve the client of the obligation to pay any outstanding charges assessed to the client's account. Clients with an account in default agree to pay Curious Concepts reasonable expenses, including legal fees and costs for collection by third-party agencies, including legal fees and costs for collection by third-party agencies, incurred by Curious Concepts in enforcing these terms and conditions.

Termination

Termination of services by the client must be requested in a written notice and will be effective on receipt of such notice. E-mail or telephone requests for services will not be honoured until and unless confirmed in writing. The Client will be invoiced for design work completed to the date of first notice of cancellation for payment in full within thirty (30) days.

Copyright

The Client retains the copyright to data, files and graphic logos provided by the client, and grants Curious Concepts the rights to publish and use such material. The client obtains permission and rights to use any information or files that are copyrighted by a third party. The client is further responsible for granting Curious Concepts permission and rights for use of the same and agrees to indemnify and hold harmless Curious Concepts from any and all claims resulting from the client's negligence or inability to obtain proper copyright permissions. A contract for website design and/or placement shall be regarded as a guarantee by the client to Curious Concepts that all such permissions and authorities have been obtained. Evidence of permissions and authorities may be requested.

Training

Each content-management website comes with 2 hours of training. Any training afterward will be invoiced as per our hourly rate.
